The above orders, made on 4th July 2014 under Section 119 of the Highways Act 1980, will divert (1) part of public footpath no. 26a at East Grinstead commencing at its junction with Dunnings Road (grid reference 539245 136837) and extending south westwards on the present access to the Dunnings Mill public house for approximately 20 metres to grid reference 539225 136835 and substituting for that path a new length of public footpath with a width of 2 metres commencing on Dunnings Road just south of the north eastern end of the length of path proposed to be stopped up (grid reference 539245 136837) curving generally westwards for approximately 22 metres along a new footway to join the southwestern end of the length of path to be stopped up (grid reference 539225 136835) and (2) part of public footpath no. 26a at East Grinstead commencing at a point approximately 34 metres south west of its junction with Dunnings Road (grid reference 539211 136835) extending northwestwards for approximately 38 metres to grid reference 539177 136857 and substituting for that path a new length of public footpath with a width of 2 metres commencing at the southeastern end of the length of path proposed to be stopped up (grid reference 539211 136835) curving northwestwards for approximately 40 metres along a new footway to join the northwestern end of the length of path to be stopped up (grid reference 539177 136857).

If the orders are sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the orders.
